- v) Ms Rankapole be requested to apply for indigent status as she is unemployed.

- b) it be noted that the transfers of funds within the same vote are delegated to the municipal manager and this can be done when the need arises during the budget vear under review.
- c) before an order for store items is issued the manager: technical and/or the manager: electrical services must approve the RFQ's to prevent excessive prices for store items which is having a direct impact on the budget.
- d) if a consumer is in arrears on his rates, taxes and other services the selling of prepaid electricity be reduced to 30% of the amount received and the rest allocated to the arrear account till the full outstanding amount has been paid or an installment agreement has been signed and if defaulting on the arrangement agreement the selling of pre-paid electricity will be reduced again with immediate effect.
- e) all accounts of Governments Departments be consolidated in terms of section 102 of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) and after 14 days notice the electricity be disconnected.
- f) the possible cash flow problem that the municipality might encounter, be noted and therefore the speedy recovery of outstanding debt must be ensured.

g) the IDP be amended as follows:

remove the R8 million from Mokopane Sewer – MIG funding add Dilotswane Taxi routes for R 4 million – MIG funding add Mapela Taxi routes for R 4 million – MIG funding add Rehabilitation of Thabo Mbeki road R 1,5 million – Equitable share remove the call centre R 1,449 million – Office of the Premier remove installation of streetlights Mahwelereng R2 million – NDPG

- h) in terms of Government Gazette no. 32959 dated 17 February 2010 the municipal manager be authorized to transfer R400 000,00 from identified savings to vote 0007311010030 (Overtime licences) and the income vote 0007312200020 (Licence fees direct) be increased with R200 000,00.
- i) an amount of R260 000,00 be transferred from vote 0001461121940 (Valuation roll) to vote 0003571120080 (Audit fees) which is not included in the GG 560 report and the schedules be amended accordingly before submission to Provincial and National Treasury.
- j) that councillors be workshopped within two weeks on the MIG projects funding for 2010/2011 which were rolled forward and the attachment of movable and immovable properties where debtors are in arrears.
